

Upon receipt of the roll and warrant by you, and on or before the first of June, you shall cause to be published in the official paper of the Village once a week for two consecutive weeks, a notice that such Tax roll and warrant have been left with you for the collection of taxes therein levied, and shall designate one or more convenient places in the Village where you will receive taxes from June first and including **June 30th** from nine o'clock in the morning until four o'clock in the afternoon, Monday - Thursday and Fridays from 9:00 a.m. – 12:00 noon except Saturdays, Sundays, and Holidays.

For said period of time you will receive all taxes paid to you without additional charge.

On all such taxes remaining unpaid after **June 30th** interest of five per centum shall be added for the month of July and an additional one per centum for each month and fraction thereof thereafter until October 31st.

After the **30th** day of June, you shall proceed to collect the remaining unpaid with interest as herein provided, but without any other fee or charge, and for that purpose you are possessed of all powers of a Town tax collector.

All interest collected shall belong to the Village.

You are to make a return of this warrant on or before the 1st day of November after the delivery thereof to you, showing the total amount of taxes paid and each tax unpaid with the receipt of the Village Collector for all taxes paid to her, and shall file the roll and warrant in the office of the Village Clerk.

And for doing this shall be your sufficient warrant.
